In consideration of allowing me to operate a go-kart at Track 21, I hereby release Track 21, its members, agents, employees, landlord, successors or assigns, from any and all liability, claims, demands, actions and causes of action whatsoever, whether foreseen or unforeseen, arising out of or related in any way to my renting and operating a go-kart at Track 21 that may result in injury, death or property damage or loss or other damages to me or my family, estate, heirs or assigns and further to save and hold harmless Track 21, its members, agents, employees, landlord, successors or assigns, from all liability whatsoever for personal injury, property damage or loss or wrongful death caused by its negligence.

I understand that this activity is dangerous and may become more hazardous or dangerous during the time I am on the premises of Track 21, that the risk of injury from the operation of a go-kart is significant, including the potential for serious bodily injury, paralysis and death; that I am aware of all the risks and hazards inherent with any operating a go-kart at Track 21 and hereby voluntarily assume all risk of loss, damage and injury, including death, that may be sustained by me or any property of mine while at Track 21.

This release shall be binding upon my family, estate, heirs or assigns. This release shall continue in effect each time I operate a go-kart at Track 21.

In signing the foregoing Liability Release, I acknowledge and represent:

- (a) That I have read the foregoing Liability Release, understand it and sign it voluntarily;
- (b) That I am at least 62 inches tall for the adults karts.
- (c) That I am not pregnant;
- (d) That I have not consumed alcohol or drugs, which may affect my ability to drive a go-kart in a safe manner;
- (e) That I do not suffer from a heart condition, high blood pressure or other medical condition which may be aggravated by my operating a go-kart;
- (f) That I will wear a helmet and **enclosed shoes** while operating a go-kart or otherwise while in or around the racetrack;
- (g) That I will stay seated in the go-kart with the safety belt fastened until instructed by a track official to remove the safety belt and get out of the go-kart;
- (h) That I will obey all rules and regulations of Track 21
- (i) That I will closely observe and follow the instructions of all facility personnel and posted signs.
- (j) That this agreement is continuing and shall remain in effect every time I use this facility;
- (k) **That I am 18 years or older with identification stating my date of birth.**
